## Redistricting Changes

This year we are running elections based on the new redistricting lines. The biggest change is we now have 14 Legislative Districts instead of 15. This mainly affects the City of Ithaca. Previously each Ward was a Leg District, but now 4 Leg districts are divided among the 5 Wards. Outside the City, the Leg lines have only shifted a little.

At the Election District level, the Town of Enfield now has 3 EDs (previously 2), Newfield now has 3 EDs (previously 4), and Dryden has 10 (previously 11). In the City, the 4th Ward is all one ED, (previously 3) and the 5th Ward now has 3 EDs (previously 4).

Of course we will provide you with maps at the poll sites, but you can look online if you want to see the new districts. Go to [votetompkins.com](http://votetompkins.com), select "Additional Information" and look for map links.

## Poll Site Changes

As part of the redistricting effort, we also have some poll site changes. In Caroline we will no longer use the Brooktondale Community Center or the Caroline Town Hall. Voters who went to those sites will now go to the Brooktondale Fire Hall, located at 786 Valley Rd. This is an excellent new site with lots of room and good lighting inside, and plenty of parking outside.

In Dryden, we will no longer use Reach Out For Christ Church, and in Town of Ithaca we won't use Hasbrouck Community Center. We will mail these voters info about their new sites, and of course they can call us.

ED lines have shifted slightly in a number of places, so some voters will be going to a new or different poll site. We will do our best to get the word out, but inevitably a few people will go to the wrong place. Please be very careful when you send them to their new poll site — do not rely on any old maps or lists. If you have a Slate or laptop with a current voter database, you can check by name, or by their new address if they have moved. But if you have ANY doubt at all about where someone should go, please call the BOE. Voters get very upset if someone sends them to the wrong site, especially if it's the second site they've been to!

## Important Dates

### September 10: Primary Election (where applicable)

Polls open noon to 9 p.m. (Poll site managers arrive at 11:00 a.m., inspectors at 11:30) *Please note: we won't know until the end of July which municipalities will have Primaries, so we can not make your work assignments until then.*

### November 5: General Election

Polls open 6 a.m. to 9 p.m. (Poll site managers arrive at 5:00 a.m., inspectors at 5:30)

## Election Worker Voting

Current law says Election Workers who need to vote absentee can not do so earlier than 2 weeks before an election. This law may change to allow even earlier voting. We will let you know if it does.



## Start Up Procedure Changes



Poll Site Managers please note that the voting machine start up procedure is a bit different this year. After you turn on the machine and use your security Key you will see a prompt that says “Please Enter Security Code to Unlock Device.” We will give you the code at your training.



After you enter the code you should see “Security Key has Been Verified” and then “Key Accepted, Validating Election Files.” Next, you will be prompted to verify the current date and time. If it is not correct, please contact the BOE before you go any further.



Also, note that we will not be resealing the ballot box door until you close up at the end of the night. This will make it easier if you need to get in to the box to clear a jam, etc. But otherwise the door must remain locked.
