### 8.5" x 11" Course Completion Certificates – Information for Health and Safety Services Instructors

Using the new American Red Cross Learning Management System, learners may receive 8.5" x 11" certificates and/or wallet-size certificate cards. Details include:

#### New American Red Cross 8.5" x 11" Certificate Information

8.5" x 11" certificates are equivalent to the wallet-sized certificate cards.

Certificates meet the guidelines for certification in a course and are an acceptable form of for learners to show certification in a particular course.

Learners may get a wallet card in their class and may also print out an 8.5" x 11" certificate from their American Red Cross Learning Management System transcript.

There are two versions of the 8.5" x 11" certificate:

- Learners may print the certificate from their transcript (prints one component per page for Health and Safety Services courses).
- Instructors or Red Cross chapters may print one page per person from the Course Record tab in the American Red Cross Learning Management System with all components on one page (for Health and Safety Services courses).

The IACET symbol indicates a continuing education certificate.
