# Update of FTA 5307 Table-FFY 2024

The Policy Committee of the Ithaca-Tompkins County Transportation Council (ITCTC) approved an amendment to the 2023-2027 Transportation Improvement Program (TIP) on April 16, 2024, during a regularly scheduled meeting. The amendment was reviewed and approved by the ITCTC Planning Committee on March 19, 2024. The actions on the ITCTC's 2023-2027 TIP include amending six activities to the Section 5307 Urban Formula Program. The changes to the current State Transportation Improvement Program (2023-2027 STIP) affect Section 5307 activities to the FTA Tables for FFY 23/24, as described below and in the attached table.

## **Description:**

Tompkins County, in coordination with TCAT and NYSDOT, requests the ITCTC approve the 2023-27 TIP/STIP amendment to the FTA Tables in FFY 23/24. The amendment allocates remaining balances from FTA Sec. 5307 funding from FFY 20/21 and 22/23 to FTA Sec. 5307 for FFY 23/24, on behalf of Tompkins Consolidated Area Transit, Inc. (TCAT). The funds will be allocated for five new projects and one existing project as shown below.

Five New Projects:

- Operating Assistance TCAT.
- Transit Facility Parking lot rehab project
- TCAT office space project
- TCAT Boiler replacement project
- Bus transmission/ engine replacement

One Existing Project:

• TCAT replacement cars

Funds totaling \$251,982 from FFY 20/21 and \$1,126,856 from FFY 22/23 will be used, for a total of \$1,378,838 being allocated to the above six projects in FFY 23/24.

The proposed amendment to the 2023-2027 TIP and the 2024 STIP are shown in Attachment A table. The table shows the projects as they will appear in the TIP and STIP. The TIP and STIP will remain fiscally constrained.

# Hector Street Culvert Project – Funding Increase

The Policy Committee of the Ithaca-Tompkins County Transportation Council (ITCTC) approved an amendment to the 2023-2027 Transportation Improvement Program (TIP) on **April 16, 2024**, during a regularly scheduled meeting. The amendment was reviewed and approved by the ITCTC Planning Committee on **March 19, 2024**. The action on the 2023-2027 TIP and the current State Transportation Improvement Program (STIP) affects one (1) project as described below.

#### **Description:**

The City of Ithaca, in coordination with NYSDOT, is requesting an amendment to increase funding for the Hector Street Culvert Rehabilitation-PIN 375701 project by utilizing STBG-FLEX funds from regional sources outside of Tompkins County, as well as 100% LOCAL city funds. The changes are as follows.

- 1. Increase funding for FFY 24/25 Construction phase by a total of \$800,000.
- 2. New FFY 24/25 ROW Acquisition phase composed of \$4,750 in 100% LOCAL funds.
- 3. New FFY 24/25 ROW Acquisition phase composed of \$13,250 in 100% LOCAL funds.

## New MEP/ATC Project-Diesel Bus Purchase

The Policy Committee of the Ithaca-Tompkins County Transportation Council (ITCTC) approved an amendment to the 2023-2027 Transportation Improvement Program (TIP) on April 16, 2024, during a regularly scheduled meeting. The action on the 2023-2027 TIP and the current State Transportation Improvement Program (STIP) affects one (1) project as described below.

## **Description:**

Tompkins County requests that the ITCTC approve a 2023-27 TIP amendment to the NYS Accelerated Transit Capital (ATC) and Modernization & Enhancement Program (MEP) Summary Table. The amendment adds one new project allocating MEP and ATC funding from FFY 20/21, 21/22, and 22/23 to FFY 23/24, on behalf of the Tompkins Consolidated Area Transit, Inc. (TCAT) and Tompkins County for the purchase of five new diesel buses. MEP and ATC are 100% State funds and are included in the TIP for information purposes.

A total of \$1,812,252 in MEP funds and \$773,183 in ATC funds are being programmed for the new project. The table in Attachment A includes the project as it will appear in the TIP (note: changes shown in bold). This amendment will not affect the funding of projects within any other jurisdiction. The TIP and STIP will remain fiscally constrained.

## Amendment to 2024-2025 UPWP

**Report:** The ITCTC received notice from NYSDOT main office that 'actual' FTA apportionments resulted in a \$747 reduction in available FTA funds for the ITCTC budget for 2024-25. FTA requires that our budget exactly match available funds, therefore we must process an amendment reducing our FTA budget by \$747. Attached is a resolution to amend the UPWP. The \$747 reduction will be assigned to the Travel/Training budget line.

Action Requested: Policy Committee approval of Resolution 2024-04, Approving Amendments To The 2024-2025 Unified Planning Work Program.

## **RESOLUTION 24-04**

## APPROVING AMENDMENTS TO THE 2024-2025 UNIFIED PLANNING WORK PROGRAM

- WHEREAS, federal legislation requires that Metropolitan Planning Organizations be established in each urbanized area of over 50,000 in population; AND
- WHEREAS, the *Ithaca-Tompkins County Transportation Council* has been designated by the Governor of the State of New York as the Metropolitan Planning Organization for the Ithaca-Tompkins County Urbanized and approved Metropolitan Planning Areas; AND
- **WHEREAS,** federal transportation legislation requires Metropolitan Planning Organizations to carry out a "*continuing, cooperative, and comprehensive*" urban transportation-planning process that addresses all modes of transportation; AND
- WHEREAS, in order to implement a continuous, cooperative, and comprehensive transportation-planning process in the Ithaca-Tompkins County Metropolitan Area, the *Ithaca-Tompkins County Transportation Council* has developed and adopted the 2024-2025 Unified Planning Work Program, which is in accordance with federal requirements; AND
- WHEREAS, the New York State Department of Transportation (NYSDOT) has updated the 2024-2025 Federal Transit Administration (FTA) Section 5303 Allocations to Metropolitan Planning Organizations based on the latest posting of the Section 5303 Metropolitan Planning Program apportionment by the FTA; AND
- WHEREAS, the updated allocations to the Ithaca-Tompkins County Transportation Council result in a decrease of \$747 in 2024-2025 FTA funding to the UPWP Operating Budget;
- NOW THEREFORE BE IT RESOLVED, that the *Ithaca-Tompkins County Transportation Council* does hereby amend the FTA funds in the 2024-2025 Operating Budget (Table 2) to accommodate a decrease of \$747 by reducing funding for the TRAVEL/TRAINING budget line by that total amount. This budget adjustment is to be reflected across the 2024/2025 FTA Section 5303 Auditable Budget (Table 4). The updated budget tables are included in the attachment to this resolution.

At 1:08 p.m. Rod Howe assumed the Chair and asked if there were any members of the public present who wished to speak.

## I. <u>Public Comment Period</u>

**Report:** Niki Frisko, Director of Bike Walk Tompkins, thanked the ITCTC and commented on the \$15,000 of funding for their agency included in the proposed ITCTC 2024-2025 UPWP. They explained that the funds will be used to promote bicycle safety, maintenance, and skills training throughout the county; included in this will be events featuring the distribution of free bicycle safety equipment, free bike repairs, and multi-modal transportation mentoring. Rural communities and populations affected by financial barriers to reliable transportation will be targeted, but assistance will be available to everyone. They added that events will take place during the May to October season.

Michelle E. Wright, Town of Ulysses, offered to distribute information about events on the town list-serve.

**Report:** Rod Howe asked the committee members to review the action summary from December 19, 2023. Michelle E. Wright asked for a correction on page 26, Item XII. 1., replacing BUILD NY with BRIDGE NY.

*Action:* The <u>Action Summary</u> from December 19, 2023 was <u>Moved</u> by Mike Lane, seconded by Dave Smith, and unanimously approved by the ITCTC Policy Committee with modification to page 26.

#### III. Approval of 2024-2025 UPWP and Resolutions 2024-01 and 2024-02

**Report:** The Planning Committee reviewed and recommended the draft 2024/2025 UPWP for approval during its January 16,2024 meeting. The Policy Committee must approve a final UPWP during their February 13, 2024 meeting in order to meet the NYSDOT deadline of March 1. A copy of the draft UPWP was sent to NYSDOT's MPO Bureau for comments and their feedback will be incorporated in the document.

Fernando de Aragón reported that the draft UPWP includes the following project for use of the required 2.5% *Set Aside for Safe and Accessible Transportation Options.* No other proposals were submitted. The total available is **\$9,469.** As required by NYSDOT, a footnote was added to Table 3, page 23.

• Expand the bike parking survey performed in the City of Ithaca area to include all municipal populations centers in Tompkins County, plus Cornell, Ithaca College, and TC3. The work will be performed by Bike Walk Tompkins, a program of the Center for Community Transportation. Project outcome will be survey data and an interactive map of bike parking facilities in Tompkins County.

Fernando de Aragón further reported:

- The principal staff-led initiatives for 2024-2025 will be the LRTP update and the TIP update.
- The TIP update process is expected to begin in the fall of 2024 with an estimate of available funding and a call-for-projects.
- Final TIP approval will take place in June 2025.
- Car Share will be re-starting business in March or April 2024..

Rod Howe called for two votes, one each for resolutions 2024-01 and 2024-02.

*Action:* Resolution 2024-01, *Approval Of The 2024-2025 ITCTC Operating Budget,* was <u>Moved</u> by Jennifer Biloski, seconded by Dave Smith and approved by consensus.

*Action:* Resolution 2024-02, *Approval Of The 2024-2025 Unified Planning Work Program,* was <u>Moved</u> by Ronny Hardaway, seconded by Dave Smith and approved by consensus.

- WHEREAS, in order to support the elements of the 2024-2025 Unified Planning Work Program, the *Ithaca-Tompkins County Transportation Council* continues its designation of the New York State Department of Transportation to be the grant applicant on its behalf; AND
- WHEREAS, the New York State Department of Transportation has agreed to apply for necessary regular program funding under the Federal Transit Administration Section 5303 program, under the Federal Transit Administration Section 5307 program, and under the Federal Highway Administration "PL" transportation planning program in amounts consistent with this approved 2024-2025 Unified Planning Work Program;
- **NOW THEREFORE BE IT RESOLVED,** that the *Ithaca-Tompkins County Transportation Council* hereby approves the 2024-2025 Unified Planning Work Program and directs the submission thereof to the appropriate Federal and State agencies and directs the filing of the appropriate grant applications to support the program;

#### Update of FTA 5307 Table-FFY 2024

### V. 2023-2024 UPWP Amendment – Resolution 2024-03

**Report:** Two unanticipated salary/fringe budget items have been recently identified and are addressed in Resolution 2024-03. The resolution reprograms carry-over funds to accommodate these unanticipated expenses. The items needing action are:

- Fernando de Aragón, Staff Director of the ITCTC, formally retired from the NY State Local Retirement System on August 19, 2023. To complete the retirement process, Tompkins County, as the ITCTC host agency, was required to pay for the accumulated fringe time (vacation & personal) as of the retirement date, an amount totaling \$8,835.12.
- Tompkins County has completed an evaluation and update of salary pay scales. The Transportation Analyst position pay scale was adjusted from pay grade 13 to 14. The resulting increase in pay amounts to \$6,114 combined salary and fringe. The increase is retroactive to January 1, 2024. This UPWP amendment accounts for the period from January 1-March 31, 2024, adding to the budget a total of \$1,100 salary and \$500 fringe.

Resolution 2024-03, below, describes the changes and shows the updated budget tables for the 2023-24 UPWP. Table 2 shows the proposed changes in **bold**.

- WHEREAS, Fernando de Aragón, Staff Director of the *Ithaca-Tompkins County Transportation Council*, formally retired from the NY State Local Retirement System on August 19, 2023; AND
- WHEREAS, to complete the retirement process, Tompkins County, as the *Ithaca-Tompkins County Transportation Council* host agency, was required to pay for the accumulated fringe time (vacation & personal) as of the retirement date, an amount totaling \$8,835.12; AND
- **WHEREAS,** Tompkins County performed an evaluation and update of salary pay scales and determined that the Transportation Analyst position pay scale will increase from pay grade 13 to pay grade 14; AND
- WHEREAS, the Transportation Analyst salary increase will be paid retroactively to January 1, 2024 resulting in an increased salary and fringe expense from January 1, 2024 to March 31, 2024 of \$1,100 in salary and \$500 in fringe; AND
- WHEREAS, the Ithaca-Tompkins County Transportation Council has access to Federal Highway Administration (FHWA) carry-over funds that can be reprogrammed to cover agency operation expenses;

- NOW THEREFORE BE IT RESOLVED, that the Ithaca-Tompkins County Transportation Council does hereby amend the 2023/2024 Unified Planning Work program by increasing the FHWA Auditable Budget by \$9,100 for the PERSONNEL budget line, and \$500 for the FRINGE/LEAVE budget line. These fund transfers are to be reflected in the 2023/2024 Ithaca-Tompkins County Transportation Council Operating Budget with an increase of \$9,100 to the "Combined Salaries" budget line under 'Expenses', an increase of \$500 to the "Fringe" budget line, and an increase of \$9,600 to the "Reprogrammed Funds" budget line under 'Revenues'; and an increase of \$9,600 to federal FHWA P.L. funds and corresponding state and local match adjustment in the 2023/2024 Programmatic Funding Summary table. These changes are shown in bold in the attachment to this resolution.

# VI. <u>Director's Report</u>

**Report:** Fernando de Aragón reported the following:

- Priority Trails Strategy.
  - Updated, presented to Tompkins County Legislature and accepted.
  - o Included in the LRTP and will help guide multi-use trail work countywide.

#### • LRTP Update.

- Expecting a contract soon with the graphic designer.

#### • Census / Urbanized Area.

- o The past census used housing density but allowed for adjustments.
- A map of the urbanized area per the 2020 census was projected during the meeting; after adjustments the result was a larger, connected urbanized area with a population of 59,102.
- The next step is to work with NYSDOT to develop a map of the functional classification of roads.
- Mike Lane asked if a map could be produced with the municipal boundaries and an overlay of the urbanized area. Fernando de Aragón replied that the ITCTC can produce that map.

## VII. Member Reports

Report:

#### 1. David Smith (*NYSDOT Region 3*).

- Route 13/34/96 project is progressing with design approval and a public meeting soon.
- Bridge NY applications are being received now.

#### 2. Tim Logue (City of Ithaca).

- Spring means the start-up of bridge and paving work soon.
- A public meeting on the Build Grant Route 13 project will be announced soon.
- Fernando de Aragón asked if the Build Grant project was going to include Carpenter Park, the old DOT site, and the Farmer's Market areas, including bus access. Mr. Logue replied that the project is mostly on Route 13, there was some discussion about including up 5<sup>th</sup> Street but the focus is on the main corridor; they are not yet looking at the waterfront. He added that bus access would be from a site plan review. Matthew Rosenbloom added that, in his previous conversations with Erin Cuddihy, he was told that later phases could include access to Carpenter Park but service would have to be suspended during construction.

#### 3. Ruth Groff (Town of Lansing).

• Ludlowville Road by the middle school has been washed out for years and unusable. It will be an approximately \$2 million project so the town is looking for funding sources. An open house will be held soon to explain why it is such a costly project.

#### 4. Mike Lane (Tompkins County Legislature).

- Dryden village is being watched for housing development and maybe more grants.
- North Street and Route 13 intersection needs improvement; looking to work with DOT on its issues as more housing in the area will produce more traffic and more problems.

#### 5. Jason Leifer (Town of Dryden).

• Freese Road and the pedestrian bridge on Route 13 are waiting to progress.

#### 6. Fernando de Aragón (ITCTC).

• The village of Dryden applied in January for funding for sidewalks; it's being reviewed now.

#### 7. Matthew Rosenbloom (TCAT).

• TCAT is excited about the new software and upgrades for the facility.

#### 8. Jennifer Biloski (Village of Cayuga Heights).

- Walking Safe project in Cayuga Heights is hoping for construction in June and completion by the fall.
- The village had a meeting with Hunt Engineers regarding Cayuga Heights Road; a public meeting will be held in August, hoping for design approval by October and completion by 2026.

#### 9. Michelle E. Wright (Town of Ulysses).

• Working on culvert review.

#### 10. Ronny Hardaway (Village of Lansing).

• Cedar Lane sewers all in the ground and resurfacing of the roads will occur in the spring.

#### 11. Joe Slater (Town of Ithaca).

• Survey work is being done on Townline Road.
