Call to Order

Mr. Pronti, Board Chairperson, called the meeting to order at 8:35 a.m.

Mr. Pronti reminded all Board members at the next Board meeting on Tuesday, June 25 it is important to attend. The Board will need to have a quorum to approve the WIOA 2024-2025 Fiscal Budgets for Workforce Development and WIOA Service Providers.

Board Action Items

Approval of Minutes - April 23, 2024

Due to lack of voting Board members present to achieve quorum the vote to approve minutes for April 23, 2024 were tabled until the next meeting Tuesday, June 25, 2024.

Workforce Development Director Update

WIOA Legislation Updates

Mr. Sponn reported NYATEP had several meetings related to WIOA Reauthorization in the Senate. As far as the timeline, NYATEP was told there is a goal to have legislative language/text released by the end of May. That could lead to HELP Committee action in mid-to-late June. Senator Bernie Sanders' HELP Committee staff made it clear they do not support the training requirement that restricted spending.

Deputy Director of Career Center Interviews

Mr. Sponn reported the Deputy Director of Career Center interviews will be next week. Mr. Sponn is scheduling interviews for 3 candidates.

Application for NDWG for Opioid Crisis

Mr. Sponn reported Workforce Development applied for a National Dislocated Worker Grant (NDWG) opportunity with NYSDOL. The grant would provide funding for those impacted by the Opioid crisis and even those who know individuals impacted. Funding can go towards training funding and work experience opportunities. Currently there are no updates to a funding announcement.

CNY Build Collaborative Meetings

Mr. Sponn reported Ms. Szabo of IAED is working to create Tompkins Build that will be structured similar to Syracuse Build for construction and trades. The CNY Build meetings include Mr. Sponn and Ms. Szabo for Tompkins County and other regional workforce areas from Central New York.

TCAT Leadership Meeting

Mr. Sponn reported he met with the new General Manager of TCAT, Mr. Rosenbloom, and discussed the services the department offers. Mr. Sponn was also given a tour of TCAT and learned more about the challenges TCAT faces for hiring. TCAT will have a Meet the Employer event at the Career Center and connections at all levels from both organizations have been made so both sides can collaborate with one another.

Direct to Work Graduation

Mr. Sponn reported that 6 individuals graduated from Direct to Work (DTW). For the final day, there was class in the morning, mock interviews, and a celebration party to end the day. Recruiting has already begun for the summer cohort. Applications close on July 12 with the cohort starting on July 29.

Southern Tier - Regional Business Services Team Meeting

Mr. Sponn reported he will present on the Micron Consortium at the next Regional Business Services Team Meeting. The group currently meets quarterly.

Career Pathways Project Meeting

Mr. Sponn reported the group met in May and partners discussed program updates and departmental news.

Fingerprinting Provider Update

Mr. Sponn reported he found the appropriate contact at Staples to see if they were interested in being an IdentiGo fingerprinting site. Mr. Sponn was told Staples was interested and the previous general manager left the Ithaca location.

Youth Employment Resource Team

Mr. Sponn reported the May meeting was held at Finger Lakes ReUse. The group was given a tour with Q&A throughout the tour. ReUse has several workforce programs including the summer youth employment program. The June meeting will be held at the Tompkins Workforce Development Board Office, and it will be a working meeting for a review of the draft of the internal and external resource directory being developed.

Career Center Update

Mr. Cerasaro reported that Mr. Sponn pretty well covered all that the Career Center is doing.

Mr. Sponn reported that he is collaborating with Ms. Buggs, Workforce Development Board Executive Director from Cortland and Cayuga County on an Opportunity Fair for next year and having Tompkins County businesses participate.

Mr. Sponn reported that the Summer Youth Employment Program (SYEP) is under way for the Youth team and they are working to get more worksites in the rural areas.

Mr. Sponn reported that Ms. Sloan, Ms. Rusk, Ms. Achilles, and himself met with Ms. Rice, Workforce Development Board Executive Director from Niagara County to see how their OJT program works. Ms. Rice gave a lot of ideas and guidance on how to enhance the Workforce Development process.

Mr. Sponn reported that Mx. Frost is working on brochures, business cards, signage, job webpage outreach, and will be using the television at the Career Center to promote services that the Career Center offers.

Mr. Sponn reported that the Workforce Development team and community partners are organizing an event at Ithaca High School which is called the Disability and Transition Resource Fair on Wednesday, June 5, 2024 from 4:30 to 6:30 pm.

Committee Reports

Executive Committee

Mr. Pronti reported that the Executive Committee did not meet this month and will meet Tuesday, June 4, 2024.

One Stop Operations and Oversight Committee

Mr. Sponn reported the One Stop Operations and Oversight Committee reviewed financials for Adult and Dislocated Worker programs. Mr. Sponn reported that the Committee had Mr. Lyman, Business Services Representative from the New York State Department of Labor discuss his role at the Career Center. Mr. Lyman will be speaking at a future Board meeting. Mx. Frost also provided updates on Workforce Development's Communications work and future plans.

Youth Oversight Committee

Ms. Shanks-Booth reported the Youth Oversight Committee did not meet this month. The Committee will be reviewing 2024 SYEP and youth financials.

Governance and Membership Committee

Mr. Sponn reported that the Governance and Membership Committee did not meet this month. Mr. Sponn reported that expiring Board members terms for 9 members will be reappointed at the Tompkins County Legislature meeting Tuesday, June 4, 2024.

Disabilities Workforce Committee

Mr. Tunison reported the Committee will meet Tuesday, June 11, 2024. Mr. Tunison reported the Committee has changed names and updated duties.

Unfinished Business

Mr. Sponn reported that the Deputy Director of the Board interview process has completed and there were three finalists. Mr. Sponn reported that Ms. Achilles applied and was chosen as the new Deputy Director of the Board.

Who are Underserved?

Someone who identifies as and selected *any* of the following:

- < 17 years old Age 55 or older
- LGBTQI+
- Physical or mental disability or impairment
- Limited English proficiency
- Having a fixed/low/no income

- Without a car/restricted license
- Living in a rural area
- Hispanic/Latino/Latina/Latinx
- Black, Indigenous, person of color (BIPOC)

Low-Income: 2022 annual household income of less than \$50,000.

Why do a needs assessment?

- Build on lived experience
- Limited service-provider data
- Build on existing work, looking deeper and county-wide
- ID county-wide priorities and add to recommendations for policy makers and service providers

The TENA Process

Survey Development and Distribution



Findings:

- 27 questions on survey
- 2,146 surveys analyzed
- 4 categories:
 - low income underserved,
 - low income not underserved,
 - not low income underserved,
 - not low income not underserved
- 83.3% identified as underserved



• 39.5% low income and underserved (of those who answered income question)

Connectivity

Question: In general, getting around Tompkins County for me is...



- For low-income people (regardless of underserved status) "Somewhat Easy" was most common.
- Over 20% of the low-income underserved respondents indicate that getting around the County is "hard" or "very hard".
- "Easy" was the most frequent selection of respondents with incomes of \$50,000+ (regardless of underserved status).
- Although the transportation system seems to work for many people, there is another group that finds it hard or very hard to get around.

- For low-income underserved respondents, "Bus (TCAT)" had the highest response at 44%.
- For the other three groups, "personal vehicle" was most commonly selected
- "Walking" had a significant response in all groups.
- When asked to elaborate, 195 respondents (36%) also discussed barriers associated with their chosen method. Almost half (43%, 83 responses) of those that mentioned barriers, discussed barriers within TCAT.

• For low-income underserved, the top difficulty was 'no buses when needed', followed by "no car/can't drive."

- 'Too much traffic' was the top selection for respondents with incomes of \$50,000+ who were not in an underserved group.
- Notably, underserved, low-income respondents were almost twice as likely to report experiencing discrimination as their not underserved counterparts.

Barriers to Transportation (cont.)

Question: Approximately, what percentage of your annual income do you spend on transportation in Tompkins County?



- The bulk of respondents spent 0-20% of their income on transportation.
- 15-20% of respondents in all categories spend 21%-50% of their income on transportation.

Effects of Barriers

Question: What is the biggest effect these transportation difficulties have on your life?



- "Stress" was a significant response for all groups.
- "Limited autonomy" was an important response for both underserved groups;
- Low-income underserved also highlighted "late/miss appointments."

- "Easier to get services" was the most frequent response only for those of low income underserved group (38.7%) followed by "saving money" and "happier/less stress."
- "Easier to get/maintain job" cited in 12-22% of those surveyed
- Low income, not-underserved participants cited saving money (41.5%) more often than all other groups. 15
