## Financial Report - Desk Review Joblink

Ms. Achilles reported to the Committee data on the comparison of WIOA IS/OS Youth allocations to expenditures on participants from July 1, 2021 to April 30, 2022. Ms. Achilles reported what Office of Employment and Training budgeted for in the Fiscal Budget for July 1, 2022 - June 30, 2023 is at 46% expended compared to 83.3% that OET should be at for this time of year.

## Summer Youth Employment Program - Allocation Update

Ms. Lovelace reported to the Committee that the Board has received the Summer Youth Employment 2022 allocations with a less than 2% increase from 2021 allocation.

Ms. Lovelace reported the Board has received an additional \$80,000 from The Park Foundation to fund more participants to be enrolled in SYEP for 2022.

Ms. Lovelace reported that there are 3 organizations (OET, IYB, and CCC) that will be contracting with the Board for SYEP.

Ms. Lovelace reported CCC will serve 10 Youth and contract for \$50,000, IYB will be funded \$186,568.18 and OET will be funded \$130,000.00.
