## FTA 5307 Project Funding Adjustments - 2025

The Policy Committee of the Ithaca-Tompkins County Transportation Council (ITCTC) approved an amendment to the 2023-2027 Transportation Improvement Program (TIP) on June 17, 2025, during a regularly scheduled joint meeting with the Planning Committee. The action on the 2023-2027 TIP and the current State Transportation Improvement Program (STIP) affects four (4) projects as described below.

## Description:

Tompkins County requests the ITCTC approve a 2023-27 TIP/STIP amendment to the FTA Tables in FFY 2025. The amendment increases funding for four (4) existing projects utilizing FFY 24/25 FTA Sec. 5307, on behalf of Tompkins County. The project adjustments are described as follows:

## Project Administration – PIN 382099

#### **RESOLUTION 2025-07**

#### SUPPORTING NEW YORK STATE DEPARTMENT OF TRANSPORTATION'S UPDATED TARGETS FOR PERFORMANCE MEASURES RELATED TO BRIDGE AND PAVEMENT CONDITIONS

- WHEREAS, the Ithaca-Tompkins County Transportation Council has been designated by the Governor of the State of New York as the Metropolitan Planning Organization responsible for the comprehensive, continuing, and cooperative transportation planning process for the Ithaca-Tompkins County Urbanized and approved Metropolitan Planning Areas; AND
- WHEREAS, the Metropolitan Transportation Planning final rule (23 CFR Part 450 and 49 CFR Part 613) require that metropolitan planning organizations establish performance targets that address performance measures or standards established under 23 CFR Part 490 (National Performance Management Measures), 49 U.S.C. 5326(c), and 49 U.S.C. 5329(d), to use in tracking progress toward attainment of critical outcomes for the region of the metropolitan planning organization, AND
- WHEREAS, said federal regulations require that the selection of targets that address performance measures described in 23 U.S.C. 150(c) shall be in accordance with the appropriate target setting framework established in 23 CFR 490, and shall be coordinated with the relevant State(s) to ensure consistency, to the maximum extent practicable; AND
- WHEREAS, said federal regulations require that metropolitan planning organizations establish performance targets no later than 180 days after the date on which the relevant State or provider of public transportation establishes performance targets, AND
- WHEREAS, the New York State Department of Transportation (NYSDOT) adjusted the 2025 statewide pavement performance targets for the National Highway System (NHS) in September 2024, for the following categories:
  - (1) Bridge Condition on the NHS,
  - (2) Pavement Condition on the NHS (by Interstate and Non-Interstate), AND
- WHEREAS, the NYSDOT coordinated the establishment of its targets for each of the above performance categories with the 14 Metropolitan Planning Organizations (MPOs) in New York through the New York State Association of Metropolitan Planning Organizations (NYSAMPO), AND
- **WHEREAS,** the Ithaca-Tompkins County Transportation Council may establish performance measure targets by agreeing to plan and program projects that contribute toward the accomplishment of the aforementioned State's targets, or establish its own target within 180 days of the State establishing and reporting its safety targets,
- **NOW THEREFORE, BE IT RESOLVED,** that the MPO Policy Committee has agreed to support NYSDOT's targets for Bridge and Pavement Condition as attached herein, AND
- **BE IT FURTHER RESOLVED**, that the MPO Policy Committee will plan and program projects that contribute to the accomplishment of said targets to the extent that it is practicable.

- **WHEREAS,** as the designated MPO, the *Ithaca-Tompkins County Transportation Council* is charged with conducting a *"continuing, cooperative, and comprehensive"* transportation planning process; AND

- **NOW THEREFORE BE IT RESOLVED**, that in accordance with 23 CFR 450.336, the *Ithaca-Tompkins County Transportation Council*, the designated Metropolitan Planning Organization for the Ithaca-Tompkins County, New York, Metropolitan Area, hereby certifies that the transportation planning process is addressing the major issues in the metropolitan planning area and is being conducted in accordance with all applicable requirements of:
  - (1) 23 U.S.C. 134, 49 U.S.C. Section 5303;
  - (2) Title VI of the Civil Rights Act of 1964, as amended (42 U.S.C. 200d-1) and 49 CFR part 21;
  - (3) 49 U.S.C. 5332, prohibiting discrimination on the basis of race, color, creed, national origin, sex, or age in employment or business opportunity;
  - (4) 49 CFR part 26, regarding the involvement of disadvantaged business enterprises in USDOT funded projects;
  - (5) 23 CFR part 230, regarding the implementation of an equal employment opportunity program on Federal and Federal-Aid highway construction contracts;
  - (6) The provisions of the American with Disabilities Act of 1990 (42 U.S.C. 12101 et seq.) and 49 CFR parts 27, 37 and 38;
  - (7) The Older Americans Act, as amended (42 U.S.C. 6101), prohibiting discrimination on the basis of age in programs or activities receiving Federal finance assistance;
  - (8) Section 324 of title 23 U.S.C. regarding the prohibition of discrimination based on gender; and

(9) Section 504 of the Rehabilitation Act of 1973 (29 U.S.C. 794) and 49 CFR part 27 regarding discrimination against individuals with disabilities;

**BE IT FURTHER RESOLVED,** that the 2025 MPO Self-Certification Narrative, labeled as "ATTACHMENT A" is hereby made an integral part of this resolution;

**BE IT FURTHER RESOLVED**, that the *Ithaca-Tompkins County Transportation Council* 

hereby instructs and authorizes its Staff Director to submit this resolution and all necessary documentation to the appropriate State and Federal agencies to ensure timely approval of this certification.

## 2026-2030 TIP UPDATE APPROVAL

**Report:** The ITCTC has completed an update to the 5-year Transportation Improvement Program. The new 2026-30 TIP includes 14 FHWA funded projects that are continuing from the previous TIP and four new projects. In addition, the TIP includes FTA funded projects.

The ITCTC staff, project sponsors and NYSDOT met on April 7, 2025 to review project proposals, address questions and develop a draft program. In addition, there has been substantial ongoing coordination between ITCTC staff, NYSDOT and proposed local project sponsors. The result of all these deliberations was the program of projects considered by the Planning Committee in May.

The ITCTC announced a 30-day public comment period which ran from May 1 through June 6, 2025. The draft 2026-30 TIP including descriptive text, summary tables and charts and individual project tables have been posted prominently and continuously updated on the ITCTC website.

A public meeting was held Wedneday, May 14, 2025, and the draft TIP was circulated with ITCTC members and others in the transportation sector. ITCTC staff was contacted regarding a number of corrections to text and project tables. NYSDOT has provided comments on the text that accompanies the project tables. This input has been incorporated into the text. The performance measures and performance targets section of the TIP has been updated to include the latest narrative and figures in coordination with NYSDOT and other NY MPOs.

TIP Development Process summary:

- October 23, 2024 a message was sent initiating a review of existing projects that were expected to roll over to the new TIP. A meeting of sponsors of continuing projects took place December 12, 2025.
- October 23, 2024, NYSDOT Region 3 provided the ITCTC with federal funding sub-allocations that could be used to develop the 2026-2030 TIP. These sub-allocations totaled \$30,010,000, restricted by funding type and year available.
- On January 3, 2025 a message was sent requesting initial project proposals (IPP) for new projects to be
- included in the 2026-30 TIP. Total available funds (after accounting for continuing projects) was \$16,127,000.
- March 10, 2025 Tompkins County, the designated recipient of FTA funds, in coordination with TCAT, provided a
  draft program of FTA funded projects.
- April 7, 2025 meeting to review IPPs and develop a draft program of projects.
- May 1-June 6, 2025 Public Comment Period

The draft proposed 2026-30 TIP was sent via email as an accompanying document to the agenda. It includes:

- o Text TIP process, fund categories, performance measure evaluation/targets, financial plan
- o Summary charts and tables,
- o TIP FHWA project tables,
- o TIP FTA tables and

o TIP maps

In summary, the 2026-30 TIP programs \$47,055,962 in federal FHWA funds and \$37,845,000 in federal FTA funds over a five-year period – Total Federal = \$84,900,962.

With the inclusion of state and local matches the programmed 5-year funds are as follows: FHWA=\$56,674,743; FTA=\$56,725,000; Total combined = \$113,399,743.

#### RESOLUTION 2025-05 ADOPTING THE 2026-2030 TRANSPORTATION IMPROVEMENT PROGRAM

- WHEREAS, federal transportation legislation requires that Metropolitan Planning Organizations be established in each urbanized area of over 50,000 in population; AND
- WHEREAS, the *Ithaca-Tompkins County Transportation Council* has been designated by the Governor and general units of local government as the Metropolitan Planning Organization for the Ithaca Metropolitan Area; AND
- WHEREAS, federal transportation legislation requires the development of a Transportation Improvement Program; AND
- WHEREAS, the *Ithaca-Tompkins County Transportation Council*, in accordance with 23 CFR part 450 and 49 CFR part 613, the Final Metropolitan Planning Rules jointly promulgated by the Federal Highway Administration and Federal Transit Administration, has developed a Transportation Improvement Program in conformance with §450.326 et al. of the aforementioned rule; AND
- WHEREAS, the proposed Transportation Improvement Program was developed in cooperation with the New York State Department of Transportation, local transit operators and other local transportation partners, and after consultation with local, State and Federal agencies and organizations in compliance with federal requirements; AND
- WHEREAS, the proposed Transportation Improvement Program, contains a five-year integrated program of federally funded transportation projects for the Ithaca metropolitan planning area to be implemented between October 1, 2025 and September 30, 2030; AND
- WHEREAS, the proposed Transportation Improvement Program has been developed to be financially constrained; AND
- WHEREAS, the developmental process of the proposed Transportation Improvement Program included a project evaluation process in order to facilitate the review and prioritization of project proposals; AND
- WHEREAS, the proposed Transportation Improvement Program includes a formal project selection process that constitutes an "agreed to" procedure for the selection of projects for implementation in conformance with §450.332 of the joint planning regulation; AND
- WHEREAS, there is a need to efficiently administer and implement the projects contained in this program, it is also recognized that the project costs shown on the program at this time are only reasonable estimates that may change during the course of project development; AND
- WHEREAS, all projects in the previous Transportation Improvement Program that have not been implemented in part or in whole are included in the 2026-2030 Transportation Improvement Program; AND
- WHEREAS, the proposed Transportation Improvement Program is consistent with all plans, goals, and objectives of the *Ithaca-Tompkins County Transportation Council* and shall be updated at least triennially with revisions to reflect changes in program emphasis and funding availability; AND
- WHEREAS, such agreement and consistency determinations are taken to satisfy the annual State Implementation Plan consistency requirements; AND
- WHEREAS, all Federal planning requirements relative to Title VI are being met and documented; AND

- WHEREAS, the *Ithaca-Tompkins County Transportation Council* attests and certifies that the metropolitan transportation planning process is being carried out in conformance with the requirements of the 23 CFR part 450 and 49 CFR part 613;
- NOW THEREFORE BE IT RESOLVED, that the *Ithaca-Tompkins County Transportation Council* hereby adopts the five-year Transportation Improvement Program for the period October 1, 2025 through September 30, 2030;
- **BE IT FURTHER RESOLVED,** that the *Ithaca-Tompkins County Transportation Council* certifies the annual transportation program of projects to be consistent with all current plans, and recommends the initiation of those projects and plans so specified;
- **BE IT FURTHER RESOLVED,** that the *Ithaca-Tompkins County Transportation Council* agrees to use the Transportation Improvement Program as the project selection document for implementation to satisfy project selection requirements in federal regulations;
- **BE IT FURTHER RESOLVED,** that the Transportation Policy Committee directs the Staff Director to submit this resolution and appropriate documentation of the program to those Federal and State agencies responsible for assuring its early implementation.

## IV. TIP Update

**Report**: The Transportation Improvement Program is scheduled to be updated by June 17, 2025. A call for initial highway project proposals resulted in nine proposals as listed in the IPP Submissions table below. After evaluation and a meeting of current and potential project sponsors on April 7, a draft program of highway projects was developed-see Project Directory Table (includes the two TAP projects from agenda Item III.b). The list include four new projects.

A draft 2026-2030 TIP has been prepared and has been made available for public comment. An online public meeting was set for May 14.

**Question:** C.J. Randall asked what happens to projects that do not make the cut, and Fernando clarified that they can be resubmitted for the next TIP.

Kathleen MacKenzie (Town of Caroline)

- 1. Work is continuing on the South Hill Extension rail trail.
- 2. Kathleen attended the Local Roads Extension webinar for state funds.

Brent Cross (Vil. of Cayuga Heights)

- 1. The Cayuga Heights Sidewalk Project (TAP Funds) The reason for the project delay is due to the consultant adding a year to the Scoping process in order to negotiate easements.
- 2. Hearing requests for midblock crossings. The Village is looking to develop some form of criteria for such project consideration.

Reed Huegerich (Cornell University)

- 1. The University is in the process of identifying a few crosswalks on campus that need additional safety considerations.
- 2. This week is Commencement Week, so there will be a lot of activity, especially is weekend.
- 3. A new field hockey field is moving forward and will be under construction soon.

Katrina Bergan (New York State DOT)

- 1. DOT will be letting the 13/34/96 project in two weeks.
- Katrina wanted to remind everyone to obligate as much of their projects as possible for the current Federal Fiscal Year. Anything after August 15<sup>th</sup> will be hard to obligate. She went on to list a number of projects in Tompkins County that need to meet this deadline.
  - a. **Comment:** Katie Borgella has noticed that the quality of consultant services has decreased recently.
  - b. **Comment:** Fernando let the committee know that the upcoming Joint Committee meeting would be an opportune time for members to obligate funds.
- 3. The Feds are trying to take away the Reconnected Communities funding from the City of Syracuse since they did not obligate their funds on time.

Tim Logue (City of Ithaca)

- 1. The City is close to design approval for the BUILD grant for redesigning Rt. 13.
- 2. Construction for the Black Diamond Trail extension is being pushed from 2026 to 2027.
- 3. The Active Transportation Plan is coming to a close and will be ready for adoption soon.
- 4. Addisu Gebre has been hired by DOT and has officially left the City of Ithaca.

Ruth Groff (Town of Lansing)

- 1. The town has received a grant for \$50,000 from the Park Foundation for their updated Trails Master Plan.
- 2. New York State DOT has given the green light to put up a 15-mph speed limit during school hours on Wildman Road.
- 3. The town recently had a groundbreaking ceremony for their new DPW building.

#### C.J. Randall (Town of Ithaca)

- 1. The Town executed their agreement with DOT for East Shore Drive project, and have started the preliminary design process.
- 2. The Town will be approving a Vision Zero resolution soon.

#### Katie Borgella (Tompkins County)

1. The CFA round is now open.

#### Frank Doldo (Dept. Planning and Sustainability)

1. There are a number of FTA funding a staff issue concerns due to federal policy. The best case scenario for next year is a flat funding amount.

- 2. They are going to try to get all of their projects obligated before the June 30<sup>th</sup> deadline.
  - a. Frank then asked if there is any unallocated money in the TIP that can be transferred over to FTA.
  - b. Katrina Bergan asked the ITCTC to conduct an inventory analysis to see if there are any FLEX funds available to be transferred over to FTA. She did raise concerns that even if there were funds available, the transfer would probably not be able to happen before the June 30<sup>th</sup> deadline.

## I. <u>Public Comment Period</u>

#### Report:

**Comment:** Ainsley de Wolf commented that road signs have gotten out of control in term of their size and number. She's concerned that these signs distract and cover up the natural beauty found along Tompkins County roads.

**Response:** Rod Howe mentioned that this is an issue to bring to the attention of the County and the Town of Ithaca and recommended that she get in touch with him to discuss this issue further.

**Comment:** John Eckenrode spoke on behalf of his neighbors with a request that there be a noise study analysis of the downtown and Cayuga Heights section of Rt. 13 to address residents' quality-of-life and adverse health affect concerns.

**Response:** In summary, the committee said that this will be a mid to long-term process that would require years of planning and implementation. The design upgrades to Rt. 13 will aim to slow vehicles when possible to reduce accidents, and subsequently noise.

*Comment:* Jay Lambrix asked about setting up highway noise barriers and implementing electric powertrain requirements at the state level.

**Response:** David Smith responded with saying that design guidelines do not allow for noise barriers in the particular context of Rt. 13, and that there are currently no guidelines for electric powertrains being considered at the state level.
