## IV. Adding Tompkins County as signatory to the 2018 Performance Management Agreement

**Report**: In 2018, following federal regulation requirements, the ITCTC, NYSDOT and TCAT signed a Performance Management Agreement that described each agency's responsibility to developing and sharing performance management data and targets. The document was included as an email attachment to ITCTC committee members.

During the recently implemented FTA triennial review, the FTA determined that Tompkins County, as the designated recipient of federal transit funds, should also be a signatory to the Performance Management Agreement.

Action: Moved by David Roth, seconded by Jennifer Biloski, and unanimously approved by the Policy Committee.

#### V. <u>Updating Statewide Safety Performance Measures</u>

**Report**: Federal rules require the State to set targets for five safety performance measures in coordination with MPOs. NYSDOT worked with the NY State Association of MPOs and its working groups to develop a set of targets. The Ithaca-Tompkins County Transportation Council may establish safety targets by agreeing to plan and program projects that contribute toward the accomplishment of the State targets or establish its own targets. The ITCTC, along with other NY State MPOs, has opted to support the State targets. Starting in 2017 the ITCTC has passed resolutions annually supporting NYSDOT's targets for safety performance measures. These targets have been updated in the TIP each year.

NYSDOT has developed 2026 targets for highway safety performance measures and this agenda item seeks to formalize support for these targets and amends the TIP to add the 2026 targets. Below is draft Resolution 25-09: Supporting New York State Department of Transportation's 2026 Targets for Safety Performance Measures, as well as a TIP amendment form describing how the new figures will be added to the TIP text.

#### **RESOLUTION 2025-09**

SUPPORTING NEW YORK STATE DEPARTMENT OF TRANSPORTATION'S TARGETS FOR HIGHWAY SAFETY PERFORMANCE MEASURES

- WHEREAS, the Ithaca-Tompkins County Transportation Council has been designated by the Governor of the State of New York as the Metropolitan Planning Organization responsible for the comprehensive, continuing, and cooperative transportation planning process for the Ithaca-Tompkins County Urbanized and approved Metropolitan Planning Areas; AND
- **WHEREAS**, the Highway Safety Improvement Program (HSIP) final rule (23 CFR Part 490) requires States to set initial targets for five safety performance measures by August 31, 2020; AND
- **WHEREAS,** As required by 23 CFR Part 490, New York State must set annual safety performance targets (5 year rolling averages) for five safety performance measures; AND
- **WHEREAS**, the New York State Department of Transportation (NYSDOT) has established year 2026 targets based on five year rolling averages for the following performance measures:
  - (1) Number of Fatalities,
  - (2) Rate of Fatalities per 100 million Vehicle Miles Traveled (VMT),
  - (3) Number of Serious Injuries,
  - (4) Rate of Serious Injuries per 100 million VMT, and
  - (5) Number of Non-Motorized Fatalities and Non-motorized Serious Injuries, AND
- WHEREAS, the NYSDOT coordinated the establishment of safety targets with the 14 Metropolitan Planning Organizations (MPOs) in New York through the New York State Association of Metropolitan Planning Organizations (NYSAMPO), AND
- WHEREAS, the Governors Traffic Safety Committee has adopted safety targets for number of fatalities, rate of fatalities and number of serious injuries as set forth in the Highway Safety Strategic Plan (HSSP), and NYSDOT has officially adopted identical 2026 safety targets in the Highway Safety Improvement Program annual report dated August 31, 2025, AND
- WHEREAS, the Ithaca-Tompkins County Transportation Council may establish safety targets by agreeing to plan and program projects that contribute toward the accomplishment of the State targets, or establish its own target within 180 days of the State establishing and reporting its safety targets,
- **NOW THEREFORE, BE IT RESOLVED**, that the ITCTC Policy Committee has agreed to support NYSDOT's 2026 targets for the five highway safety performance targets as attached herein, AND
- **BE IT FURTHER RESOLVED,** that the MPO Policy Committee directs the ITCT Staff Director to update the 2026-2030 TIP to include the 2026 highway safety targets, AND

BE IT FURTHER RESOLVED, that the MPO Policy Committee will plan and program projects that contribute to the accomplishment of said targets.

This resolution having been considered and approved on September 16, 2025.

# 2023-2027 TRANSPORTATION IMPROVEMENT PROGRAM \*\*Amendment\*\*

Updating Highway Safety Performance Targets for 2026 - Text Amendment

The Policy Committee of the Ithaca-Tompkins County Transportation Council (ITCTC) approved an amendment to the text of the 2023-2027 Transportation Improvement Program (TIP) during a joint meeting with the Planning Committee on September 16, 2025. The action on the 2026-2030 TIP is described below.

#### **Description:**

Federal rules require the State to set targets for five safety performance measures in coordination with MPOs. NYSDOT worked with the NY State Association of MPOs (NYSAMPO) and its working groups to develop a set of targets. The Ithaca-Tompkins County Transportation Council may establish safety targets by agreeing to plan and program projects that contribute toward the accomplishment of the State targets or establish its own targets. The ITCTC, along with other NY State MPOs, has opted to support the State targets. Starting in 2017 the ITCTC has passed resolutions annually supporting New York State Department of Transportation's Targets for Safety Performance Measures. These targets have been updated in the TIP each year.

NYSDOT has developed 2026 Targets for safety performance measures. These targets are supported by the ITCTC per Resolution 25-09: Supporting New York State Department of Transportation's 2026 Targets for Safety Performance Measures.

This text amendment to the 2026-2030 TIP follows a format as agreed by NYSDOT and FHWA in coordination with NYSAMPO. The amended text serves to update performance measure safety targets to 2026 as shown in Attachment A (underlined/strike through text) below. The TIP and STIP will remain fiscally constrained.

# **Addressing Performance Targets**

Background Unchanged

**Highway Safety** 

The FHWA Highway Safety (PM1) rule established the five performance measures for safety on all public roads. The performance measures are calculated as five-year rolling averages.

The 2023 New York Strategic Highway Safety Plan (SHSP) is intended to "promote best practices and strategies that, implemented, could have a substantial impact on reducing fatal and serious injuries crashes." The SHSP was developed through a collaborative process involving federal, state, local, and tribal safety partners. It guides NYSDOT, the MPOs, and other safety partners in addressing safety and defines a framework for implementation activities to be carried out across New York State. The NYSDOT HSIP Annual Report documents the statewide performance targets.

**Performance Targets** 

In August 20245, NYSDOT set 20256 statewide highway safety targets. Those targets are shown in

Table 1. The ITCTC agreed to support the NYSDOT statewide 20256 targets for the following safety measures on February 25, 2025 September 16, 2025, via Resolution 2025-03 Supporting NYSDOT's 20256 Targets for Safety Performance Measures.

The ITCTC agreed to support the NYSDOT statewide targets for Safety PM measures as shown in the table below, based on five year rolling averages per Title 23 Part 490.207 of the Code.of.Federal. Regulationsi.Resolutions agreeing to support statewide targets have been approved annually since 2017, with the most recent as follows:

#### **Anticipated Effects**

Safety is a critical component of the ITCTC's mission, and the projects on the TIP are consistent with the need to address safety. Safety is a primary consideration in the selection of projects to be included in the TIP. "To improve the safety of the overall transportation system" is an overarching goal of the ITCTC Long-Range Transportation Plan (LRTP). In addition, the LRTP includes goals and policies prioritizing safety as a base component of all infrastructure design. The Initial Project Proposal utilized during TIP development requires a description of each project's safety benefits regardless of funding source. HSIP funded projects include additional safety analysis. The TIP includes projects programmed with HSIP funds and other fund sources that are expected to materially benefit the safety of the traveling public on roadways throughout the metropolitan planning area. The anticipated effect of the overall program is that it will contribute toward achieving NYSDOT's safety performance targets.

FTA runs it and State DOT participates and hires consultants for a third-party review. It's a deep dive into everything associated with transit in the community.

#### 2. Frank Doldo (Tompkins County)

- The final report will be presented soon.
- They got a lot of positive feedback from the regional administrator, Michael Collata.

#### 3. Laura Lewis (TCAT)

- She just wanted to echo the comments from Frank and Katie.
- TCAT Fall service has begun.
- The new TCAT electric buses have arrived, five of which are onsite. One of them is doing an
  exhibition tour.

#### 4. David Roth (NYSDOT)

- The end of the Federal Fiscal Year is rapidly approaching, but all the needed authorization has been achieved.
- The last project on the table was the City Stewart Ave. Project.
- There are no updates regarding the Rt. 13/34/96 project. There is no meeting until December.

#### 5. Trevor Jensen (TCAT)

- There will be new updates to the fareboxes allowing people using credit cards to limit their daily bus expenditures to \$3 in total.
- This program should start in October.

#### **Question: Jennifer Biloski**

What happens with people who do not have credit cards?

#### **Response: Trevor Jensen**

As of right now, only people with apps or credit cards can access this program.

#### **Question: Jay Lambrix**

Will it be like the Rochester system where people can purchase an all day \$3 pass

#### Response: Trevor Jensen

You can already purchase an all-day \$3 pass, but this program allows people to automatically get their fares capped without having to worry about buying an all-day pass.

#### **Question: Katie Borgella**

Can people use debit cards?

#### **Response: Trevor Jensen**

Yes.

#### 6. C.J. Randall (Town of Ithaca)

Forest Home Improvement Association, along with Cornell University, has been working with
the Town to develop a traffic calming plan update, the first update since 2007. This time, they
are looking at more through an active transportation lens. They are putting out a request for

- qualification for design/planning firms.
- The South Hill Traditional Neighborhood Development They are putting out an RFQ for consultants in the next few weeks for this project.
- The Town has draft design reports almost ready for East Shore Drive.
- The design approval document under review for the Town Line Road Bridge.
- They are almost ready to convey to the State of New York the three final parcels for the Black Diamond Trail connection to Treman Park and Buttermilk Falls. They should be wrapping that up within the next few weeks.
- The Town passed the Vision Zero resolution that accompanied the Safe Streets for All final report (this report will be posted to the website shortly). They are looking to start looking at implementation of the Safe Streets for All plan.

#### 7. Kelley Chapman (Tompkins County)

• There are multiple road projects in progress

#### 8. Tim Logue (City of Ithaca)

• No updates as of this moment.

#### 9. Jennifer Biloski (Vil. of Cayuga Heights)

- T.G. Miller is continuing to work on the easement maps for the Cayuga Heights Road project.
- The Grenwook Creek culvert project design is being worked on by T.G. Miller. The culvert needs replacement.

#### 10. Ray Burger (Town of Dryden)

• Dryden Rail Trail Update – The work plan design grant of \$11,000 has been awarded for the middle stretch of the trail.

#### 11. Rod Howe (Town of Ithaca)

 Coddington Valley Trail Update – They will be sending out a request for proposals shortly. Stay tuned. This is for the stretch from Burns Road to Middaugh Road.

#### 12. Ronny Hardaway (Town of Lansing)

- Lansing Trail Update –
- The DPW crew recently upgraded Lansing Trail by widening the paths and built a new path over a culvert. They are waiting for the surface to cure, but it should be ready in a few days.
- Lansing is planning on installing a sidewalk along the north side of Kraft Rd. from Triphammer to curve at Leap's Way.
- They will be putting in a left-turn signal at the southbound Triphammer Rd. intersection before Graham Rd.

#### 13. Thomas Knipe (Tompkins County)

• Notification of Fernando's retirement party this Friday at 4:30 at Personal Best's Brewing.

#### 14. Natalie Motl (City of Ithaca)

 Cambridge Systematics will get the data from DOT, refine it, and then send it to the County to upload to the SS4A dashboard.
