FLTG Cutover -Kim reported that the ISP cutover actually went smoothly for the Citrix users. We had a reported outage of approximately an hour (instead of the "up to 48 hours" I had reported last month!)

Dispatch -Kim reported that dispatchers do not have the ability to use their pictometry/mapping features due to the ISP network cutover from three weeks ago. Kim is working with dispatch for a workaround solution, but wanted LETSS agencies to know that this is caused by network issues, not dispatch. She encouraged agencies to let their officers on the road know that dispatch is not able to map locations for officers because of this and to please be patient with dispatch as we work through this issue, which we hope to have resolved by the end of the week.
