## **APPROVAL OF MINUTES**

### Tompkins County Board of Health March 26, 2024 12:00 Noon Rice Conference Room and via Zoom

Call to Order: Dr. Moylan called the regular meeting of the Board of Health (BOH) to order at noon.

### **Privilege of the Floor: None**

**Approval of January 23, 2024, Minutes:** Mr. Kingra moved to approve January 23, 2024, minutes; second by Ms. Merkel. The vote to approve the January 23, 2024, meeting minutes as written was unanimously approved; the motion carried.

**Financial Summary:** Mr. Porter was greeted with a warm welcome of introductions by the Board in his initial financial summary report to the Board. Mr. Porter referred to the written report included in the packet with nothing to add.

**Medical Director's Report and Discussion:** Dr. Klepack was not present. On behalf of Dr. Klepack, Mr. Kruppa reported that Nassau County has identified a measles case.

Administration Report: Mr. Kruppa reported on the suspension of services at the Alcohol and Drug Council on February 26, 2024. The transitioning of clients to other care is complete and focuses on closing down the organization. Decisions are being made on all their funded services which include prevention, an outpatient clinic, and a detox/stabilization facility. Request for Proposals (RFP) will go out to find alternative providers. The County and OASAS are committed to getting the detox/stabilization facility open and the County envisions it to be a holistic model to include both mental health and substance use.

Dr. Dhundale asked that teens and youths be included in any expanded services for substance use. He will follow if youths 11-12 are included. Mr. Kruppa explained the RFP process.

Mr. Kruppa responded to a question on the 2024 budget noting that the biggest impact will be on early interventions with a proposed increase of 5% and then an additional 4% in *high-need areas*. He is unsure of what high-need areas are identified as but they were looking for an 11% increase vs. 9%.

The Opioid Settlement Funds RFP, through the Local Governing Unit (LGU), to provide wrap-around services for individuals who are active in the crisis system has closed. Catholic Charities was the selected vendor and is going through the legislature for approval.

The Outreach Worker Program RFP, which expanded to include not only the downtown area, but the entire county, has closed. The applications are under review and the program should be operational within a few months.

<u>Release of 5-Year Unintentional Fatal Overdose Data</u> - Data has been posted on the Opioid resource page of the Tompkins County Whole Health webpage <u>Unintentional Fatal Overdoses (2019-2023)</u>. The data demonstrates trends and provides relevant demographic information about those who died from drug overdose during the last five years.

The Medical Examiner's data identified demographic data for those who unintentionally fatally overdosed as an immediate cause of death. The data shows yearly totals, the months in which deaths occurred, and include demographics such as age, race and ethnicity, education level, location of death, occupational status, marital status, veteran status, and hospitalizations within 2 months before death.

Mr. Kruppa highlighted the disproportionate number of Black Americans dying from opioid overdoses (18/100) 18% and only 8% of our total population with most having occupations as food service workers. The data allows for outreach and education around that workforce population. He hopes for a larger data project where the data is not controlled by the medical examiner and will include data that does not result in death. Without the resource capacity to take Protector Health Information (PHI), they will partner with Cayuga Health Partners.

Ms. Black voiced her concern about not being informed of unavailable resources to present data on how many people are dying of overdoses in the community. She believes resources can be obtained through the legislature to hire someone to look at the data, present the data, and who will have ideas and ways to reduce overdose deaths. She believes this Board must be more proactive.

Mr. Kruppa acknowledges her concerns and agrees that more needs to be done but notes that they do not have control over outside sources. Publicized information is not always accurate, and they seek to improve communication and messaging around drug-related issues despite a lack of access to data and other challenges. He contacted the State Office of Drug User Health who reported no spikes in their database in our community.

Mr. Kruppa answered a question on the availability of NARCAN which is available at CARS, REACH Medical, STAP, the Mental Health Clinic, and local pharmacies. It is important to use data to make

informed decisions about drug use and awareness and also how to effectively use the available data. Everyone is impacted.

Suggestions/Questions from the Board - How will we use more data and what other data is needed/missing; in what ways can the Board be more proactive; should an MHP be hired to handle overdose prevention; create informational/social media platforms; reach out to other counties; and what are the next steps? Ms. Black feels we must also include an educational factor and effective ongoing communication with law enforcement and the health department.

Mr. Kruppa expresses interest in the suggestions in consideration of the development of the budget.

Dr. Moylan suggested agenda topics about overdose data for next month's meeting: A reflection on how Public Health provides information and communication strategies; How can the Board be more proactive and helpful; and how the health department can position itself relative to providing information.

**Division for Community Health (DCH) Report**: Ms. Buckwalter had nothing to add to her written report included in the packet. The CDC issued new guidance on COVID-19. She confirmed the measles case in Nassau County on an unvaccinated child who was not traveling. She noted that 95% of school-aged children are vaccinated.

DCH internally promoted a nurse to a senior nurse position and is looking to fill that current vacant nurse position. They still have one senior nurse position open.

Health Promotion Program Report: Ms. Hillson was not available.

**Children with Special Care Needs (CSCN) Report:** Jessica Clarke Manderville, reported they are gathering data from providers regarding retention and recruitment. The New York State Billing System is transitioning to a new system in June 2024 which may cause some challenges.

Environmental Health Report: Ms. Cameron had nothing to add to her report.

### ENVIRONMENTAL HEALTH Enforcement Actions:

**Draft Resolution #EH-ENF-23-0027 - Pizza & Bones, Violations of Subpart 14-1 of the New York State Sanitary Code (Food Service)** – Dr. Dhundale moved to accept the friendly amendment; seconded by Dr. Koppel.

Ms. Cameron said this is a friendly amendment to change the date from May 15<sup>th</sup> to June 15<sup>th</sup>.

All were in favor of the friendly amendment to change the date from May 15<sup>th</sup> to June 15; the vote to approve was unanimous.

**Draft Resolution #EH-ENF-24-0001 - Argos Inn, Violations of Subpart 7-1 of the New York State Sanitary Code (Temporary Residence)** – Ms. Merkel moved to accept the friendly amendment; seconded by Dr. de Lima. All were in favor of the friendly amendment to change the date from April 15<sup>th</sup> to May 15; the vote to approve was unanimous.

# **MEDICAL DIRECTOR REPORT**

## **Community Engagement**

### PRESENTATION

On April 9th I delivered a presentation to a small audience at Lifelong regarding harm reduction, substance use disorder with reference to cannabis, and MRTA (the Marijuana Restitution and Taxation Act of 2021).

## **Communicable Disease Report**

Notably Lyme disease continues to be reported at a higher incidence than prior years. My practitioner bulletins emphasize this and our public health messaging.

Reminder: RSV is a new addition to the report which is why zero cases show for prior years.

### MEASLES

3 cases have been reported recently. The public is urged to ensure they are adequately vaccinated. If planning a trip internationally to a region with elevated measles risk, they should discuss preventive measures with their practitioner including vaccination of children under 12 months of age.

One case arose in an unvaccinated child acquired in the US with no international travel factors. The source of their infection remains unknown. Symptoms were fever, cough, conjunctivitis, and vomiting with the rash beginning in the region of the mouth and spreading downward and outward to the whole body. MMR had been refused on multiple occasions by the parents. This is the first case in NYS in which a resident was not related to travel. We tested many of the contacts of the index and found them to be immune. Others were born before 1957. No post-exposure prophylaxis was needed for these two groups. A total of 150 exposed individuals were uncovered by public health including some in healthcare locations. Postexposure prophylaxis was offered to susceptible contacts. One contact of that infected child has developed a fever and is being investigated as a secondary measles case. A <u>NYSDOH</u> practitioner advisory was sent out on 3/26/24.

Another case arose in a 10-month-old who traveled to Pakistan. Contacts have been traced by public health and postexposure prophylaxis has been given.

And another in an older individual was traced to an exposure in Chicago. This individual reported having had 2 MMRs.

These cases highlight the need to increase our vaccination rates in the general population, especially in young children. The target vaccination rate to prevent community spread is 95%. We are falling short of that goal as seen in the <u>NYS county map in the appendix</u>.

My practitioner bulletins often highlight the need to keep our vaccination rates up.

### INFLUENZA

As of April 9<sup>th</sup>: No further NYS pediatric deaths (total of 12 this season so far). A further decrease in cases is occurring but influenza is still widespread in 56 counties and NYC boroughs.

- 8,790 lab-confirmed flu cases, a 7% decrease from the prior week
- 44% Flu A
- 56% Flu B
- For the 20th consecutive week, it is widespread (flu cases were reported in 61 counties. 56 upstate, and all 5 boroughs of NYC)

The season is winding down but here is a *Caveat* – with the increase in the use of respiratory panels to detect disease it has become apparent that in spring/summer there is more flu around than was previously evident. In the <u>Appendix: Positive RSV lab results</u> by week, 2023-24

## H1N1 IN LIVESTOCK AND AVIAN INFLUENZA

A continuing story. So far, there are no critical issues relating to human infection from animals.

## Purchases off the web, internationally, and over the counter

The common denominator of these purchases is that they are not regulated by the FDA and their safety, and purity is not guaranteed. The risks to the public are many (e.g., bacterial/viral contamination, lead, and other toxic chemicals being in them). Here are two examples:

- Infection: Mycobacteria infection was acquired from a product purchased online.
- Lead poisoning: woman dies of lead exposure from a skin cream purchased internationally <u>https://www.cdph.ca.gov/Programs/CCDPHP/DEODC/EHIB/Pages/EIS/Alert-Hemorrhoid-</u> <u>Ointment-from-</u> <u>Vietnam.aspx#:~:text=A%20woman%20in%20Sacramento%20developed,Lead%20is%20toxic</u>

All treatments, and supplements purchased over the counter, by the web, or otherwise internationally should cause the purchaser to be wary and have a health professional look at the ingredients and comment on the wisdom of the purchase.

# **COMMISSIONER SHARED REPORT**

## Whole Health Highlights

- We are preparing to launch our first CFTs (cross-functional teams) under the new Strategic Plan! These teams will be focused on topics such as internal efficiency, client needs, and communication. Currently, we're working on identifying Senior Leadership mentors and preparing the charter documents for each team. Stay tuned for more updates about the work these teams will be doing over the next few months!
- Whole Health staff recently gave a presentation to the Substance Use Subcommittee alongside some of our other community partners (including CARS and REACH). The presentation focused on our recently released data around Unintentional Overdose Fatalities, and featured a recap of funded Opioid Settlement projects as well as reviewed the community feedback collected by the OTF. Moving forward, we aim to continue this dialogue with the Subcommittee and other community partners as we work to enhance our data project with upstream indicators.

## CULTURE:

Align the organization around our shared mission and values-based culture to create an empowered, engaged, and cohesive team.

 Our DEIB Cross-functional Team finalized their recommendations for Senior Leadership after meeting regularly for over six months. Some of the top recommendations included developing a framework/commitment to DEIB as an organization, as well as exploring a standardized approach to demographic data collection. This team has worked very hard to help us really dig our hands into this complex, wide-reaching topic, and we're excited to see what these teams can do next!

## COMMUNITY:

Strengthen the collaborative effort within Tompkins County to equitably impact individual and population health.

• Staff have been hard at work bringing our Community Health Improvement process (CHI Tompkins) to life! In late March, we hosted the first "Community Visioning" Event at TCPL, which had a great turnout of community members who shared their thoughts about "what makes a

healthy community". The "Community Visioning" events are a part of the Community Health Improvement Plan process.

## Highlights

### COMMUNICABLE DISEASE

- Summary of notable CD investigations in March:
  - Campylobacter: 1 case, 43 yo with a recurring abscess as well as systemic infection, not related to travel
  - Yersiniosis: 1 case, 68 yo with co-morbidities and symptom onset 6-7 weeks prior, followed by GI provider and needing medication, no hospitalization
  - Giardia: 1 case, 23 yo, with travel to three countries in S. America, required medication, no hospitalization
  - Strep Group A invasive: 2 cases: 1–76 yo, hospitalized, underlying co-morbidities, recovered. 2–5 yo, two ED visits and transfer to Upstate, recovered. Had the flu prior to this infection
  - Strep Group B Invasive: 1 case, resident of a nursing home, 83 yo with multiple comorbidities, able to return to nursing home after 7-day hospital stay

### **IMMUNIZATIONS**

- Planning is underway to provide two Covid vaccination clinics in April. There will be a clinic at Brookdale Memory Care on April 22<sup>nd</sup> and a clinic at McGraw House on April 25<sup>th</sup>. These organizations reached out to CHS due to having several residents who are homebound and do not have any other way to access Covid vaccination.
- CHS collaborated with the communications team to design ads which will run in Ithaca Teen and Ithaca Child publications in the upcoming months. These ads promote HPV vaccination and keeping up to date with routine vaccinations in preparation for back to school.

## INFECTION CONTROL

 Rachel Buckwalter, Director of CHS, participated in an infection control training called "Project Firstline" in Corning on March 6<sup>th</sup>. The goal of this training was to "train the trainer" to educate community groups on the importance of infection control. The training included information on source control, ventilation, surface cleaning, emerging strains of Covid, and proper use of multidose vials to minimize contamination. This training was sponsored by NYSACHO and included use of a CDC approved curriculum.

### ORAL HEALTH

- The Tompkins County Youth Oral Health survey is in its distribution phase and will close to the public on April 12<sup>th</sup> at 5 pm. Results from this survey will be analyzed and shared with BOH regarding dental care gaps in Tompkins County.
- Sagarika Vemprala, graduate public health fellow, presented a training to CHS nurses and community health workers at the CHS department meeting on March 21<sup>st</sup>. This training was titled "Promoting Oral Health in Home Visit Settings" and included teaching on brushing, flossing, nutrition, and fluoride use in pregnant women and young children, with the goal of preventing dental caries.

### STAFFING

- Caryl Silberman was promoted to Senior Community Health Nurse and started her new position on April 1<sup>st</sup>. Congratulations Caryl! Caryl will be managing the communicable disease program and the Moms PLUS+ program.
- There are currently two vacancies within CHS. We are recruiting for a Community Health Nurse to fill Caryl's vacated position and we are also recruiting for another Senior Community Health Nurse.

### WIC

- In March we filled the vacant WIC clerk position. New WIC clerk Bea Ives started on March 18<sup>th</sup> .
- We served 438 individuals in the month of March. There were 34 new applicants to the program, of which 25 were successfully enrolled.

## **Program Updates**

## SAFECARE PROGRAM

- One family completed the SafeCare curriculum. This is a significant accomplishment as it means the family completed 18 home visits from a nurse over the course of six months and demonstrated mastery of skills that were taught.
- We received a new SafeCare referral from DSS and have started visits with this family.

### MOMS PLUS+

• Moms PLUS+ nurses completed 44 home visits during the month of March and admitted 15 new clients to the program in March.

### IMMUNIZATIONS

- 11 adults and 14 children were vaccinated in our on-site Friday immunization clinic during the month of March.
- VFC and VFA provider agreements were submitted to NYSDOH and were approved for the next year.

#### RABIES

• 8 rabies vaccinations were administered during the month of March. These were due to exposures to bats in people's homes.

### LEAD

- The Lead Poisoning Prevention Network committee met on March 21<sup>st</sup>. The group collaborated on designing banners for display on buildings around the county that will educate the community on sources of lead and how to prevent lead poisoning. The group is also working on designing a rack card for distribution that will provide information on lead poisoning prevention.
- There are 13 children currently receiving nurse case management for elevated blood lead levels. There were no new admissions in the month of March.

### HIV

- 3 HIV tests were performed at TCWH in March
- 1 HIV test was performed at STAP in March

## Highlights

- The Health Planning Council held a community engagement meeting on March 11 where HiP Tompkins and CHI Tompkins (Community Health Improvement) presented overviews of these initiatives and opportunities for community members. This meeting also included a presentation about the Health Transformations Grant in partnership with Human Services Coalition and Cayuga Health.
- A Community Visioning event was held on March 22 during the Health Planning Council's Community Health and Access meeting. Community visioning is one of the first activities in the MAPP 2.0 process for community health improvement. The Steering Committee plans to hold other events and some opportunities for passive input from the community (eg. at libraries).

## **Staff Training:**

- Long wait list: Speech (45), Feeding (5), OT (14), PT (7), SI (24), SW (4)
- Referrals received March: 33
- El referrals received today are not able to have a core evaluation done until July or August of 2024 as there are only 4 core slots available each week. NYS had a 45-day timeline from date of referral to evaluation date. We are outside this indicator for every case.

- We reached out to past agencies that had contracted with us for cores, one is interested and is looking at their availability.
- Currently serving 192 active/qualified children in Early Intervention. 6 Total Child Find Cases
- One position for a Community Health Nurse remains open.

## Highlights

## Notices of Violation (NOVs) for Part of the Ithaca Encampment Area:

On April 9, EH issued Notices of Violation to the City of Ithaca and Watco (who manages the railroad property) for the area between Taber Street and the railroad. EH has received multiple complaints about the encampment and investigated this situation. Considering the complexity of the situation, we limited the scope of the NOVs to this area where some of the most significant violations from a public and environmental health perspective have been observed. We met with the City and Watco prior to issuing the NOVs to discuss our concerns and the focus on this area and will continue to work with them as they address this issue. In accordance with the NOV, the City and Watco will need to submit a plan and timeline by May 10 to clean up the property. The cleanup is a very complicated undertaking. Some factors include campers that have been living in the area, there is no ready vehicular access, wet weather can preclude equipment access, there are multiple types of waste materials to be dealt with and, for material in the waterways, NYSDEC permits will be required. The NOV requires initial action to be taken within 30 days of approval of the plan and a timeline for full cleanup. The NOV also requires a plan for maintaining the area.

## Falsified Water Sample Report:


On March 15, Brew 22 Coffee and Espresso/Brewer's Kitchen and Taproom, a regulated water supply and permitted restaurant, submitted a falsified laboratory report for water bacteriological samples. Brewer's handed Environmental Health Specialist Tom Palmer a laboratory report when Palmer was onsite inspecting their water system. Brewer's mentioned that they thought they had also done their annual nitrate sample. Later that day, EH reached out to Community Sciences Institute (CSI) laboratory to see if CSI had the nitrate report. During this conversation, CSI said they didn't have anything from Brew 22 after April 2023. The lab report that had been handed to Palmer was for a November water sample. We provided CSI with a copy of the lab report, who determined that the report had been falsified. CSI's letter to us is included in Resolution # EH-ENF-24-0006 on the April Board of Health agenda. As noted in the enforcement action, Brewer's submitted two additional lab reports that were also determined by CSI to be falsified.

EH was informed that CSI submitted the falsified report to the NYSDOH Environmental Laboratory Approval Program (ELAP). EH then provided a copy of the falsified report and the CSI letter to our NYSDOH Regional Coordinator. The sections of the NYS Sanitary Code enforced by EH do not specifically address the falsification of laboratory reports; however, in Resolution # EH-ENF-24-0006, Brewer's is cited for failing to exercise due care and diligence in the maintenance and supervision of their water system.

### HUMAN RESOURCES:

Environmental Health Specialist Cynthia Mosher has resigned. Her last day was Friday, March 29. On a more positive note, former Environmental Health Specialist Dillon Shults will be returning to EH starting April 29 to fill the vacancy. Dillon will be handling many of the programs that Cynthia had including the Rabies and Cooling Tower Programs. Welcome back, Dillon!

I am writing in response to your recent letter addressed to the Tompkins County Board of Health. Thank you for reaching out.

Attached, you will find the 2024 fee schedule for your reference (see page 2). Our fees are calculated based on the time spent by staff members on various types of office and field work required to generate a permit. It's important to note that approving a set of plans from an outside engineer and subsequently generating a permit generally requires more work compared to handling the work internally. This is because, as the engineer at Tompkins County Whole Health, I need to review the outside engineer's proposal thoroughly to ensure it meets all requirements.

Had we designed your system internally, the total cost for the permit would have been \$335. Our office is responsible for designing most of the sewage systems installed in this county, but we do not turn away designs submitted by outside engineers. If your contractor did not clarify this, I apologize for any confusion.

To whom it may concern,

On Monday March 25<sup>th</sup> I received a call from the Tompkins County Health Department after submitting two water sampling reports that were provided to me after having an employee drop these tests of for sampling.

I then received a call from Skip Parr, notifying me that these reports were altered, and not accurate for the samples I had instructed to be delivered.

As I was visiting my sister in Charleston, I arrived back in town the afternoon of March 25th and asked about these reports.

Back in November, we had a new employee start who had made us aware of some health issues he faced, but we had brought him on anyway as we felt he would be a good fit, and he needed employment. During these first few weeks, and offer was made that he could drop a November water sample off for us as he was working a very limited schedule due to his health and could use the extra funds to do the running around and emailing me the reports for submittal.

His health continued to decline, and as he was only working around 5-8 hours per week, I figured allowing him to deliver the samples to remove our boil water notice would get some extra money in his pocket and help me out as I was getting ready to head out of town and visit my sister.

As it turns out, an old report dated from 2022 was altered three total times, and these water samples did not get to the lab at all. The roughly \$72 per test was pocketed, and I am assuming we honestly would not have caught on unless an individual at the health department realized the issues. These forms were readily available in our email, as I have always saved any water testing report in a single folder for easy access.

While this employee was terminated, and access to our email account (<u>Brew22coffee@gmail.com</u>) removed, I do however take full responsibility for this incident, with something of importance such as water samples, this absolutely should have been a process I performed myself to ensure chain of custody, but at the same time, I did not think altering a form was a possibility.



Receipt of 1 MMR dose by 2 years of age





# 911 CALL REPORTS

All calls that come into Tompkins County's 9-1-1 center are coded based on the type of emergency. To help direct the call, the dispatcher assigns each a "Nature." The Department of Emergency Response (DoER) sends the monthly totals to Whole Health for calls coded as "Overdose/Poisoning," and these are posted in graphic form <u>on the WH website</u>.
