HR/Supervisor Consultation

- Consultations are provided in virtually every critical area of human resource management.
- Supervisors and HR Managers can access Senior Counselors and Senior Professionals in Human Resources (SPHR) when complex employee issues arise requiring specific HR expertise.

What Managers Need to be Looking for...

- Front line Supervisors and Managers are the first to notice changes in employee behavior and in the best position to address concerns with the employee
- Behaviors and presentations that are outside of the employee's normal baseline of behaviors
- Behaviors can include:
 - Excessive Absenteeism
 - Disheveled appearance
 - Unusually emotional or increased frustration/agitation
 - Inability to accept feedback in a constructive manner
 - · Seemingly stressed, tired, anxious



Supervisor Approach for Suggested (Encouraged) Referrals

- "I've noticed you seem _____"
- "I'm concerned about you and wanted to see if you're okay"
- "I'd like to remind you that you have this great EAP benefit"
 - Provide EAP information to the employee
 - Offer the employee a private place to make the call
 - Remind that it's completely confidential


Administrative Referral Program




The Administrative Referral is a formal process to address policy violations and unacceptable job performance.

- When confronted with an employee performance problem, supervisors can consult with an EAP Clinical Counselor and determine the best approach. Options include Counseling, Coaching, and Training
- More than half of referred employees return to full productivity







Administrative Referral Process

- Call the EAP and consult with one of our Clinical Counselors or SPHRs prior to making the referral
- Complete the Administrative Referral Information Sheet – HR access only-unless authorized by HR
- Meet with Employee who signs the Authorization to Release Information

Risk of Liability


Need To Know

Information should only be shared with key individuals who must know about the issue

Limits

- Avoid any attempt to diagnose the person's problem in any written or verbal statements
- Focus only on work performance
