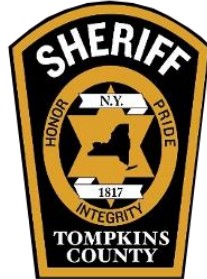

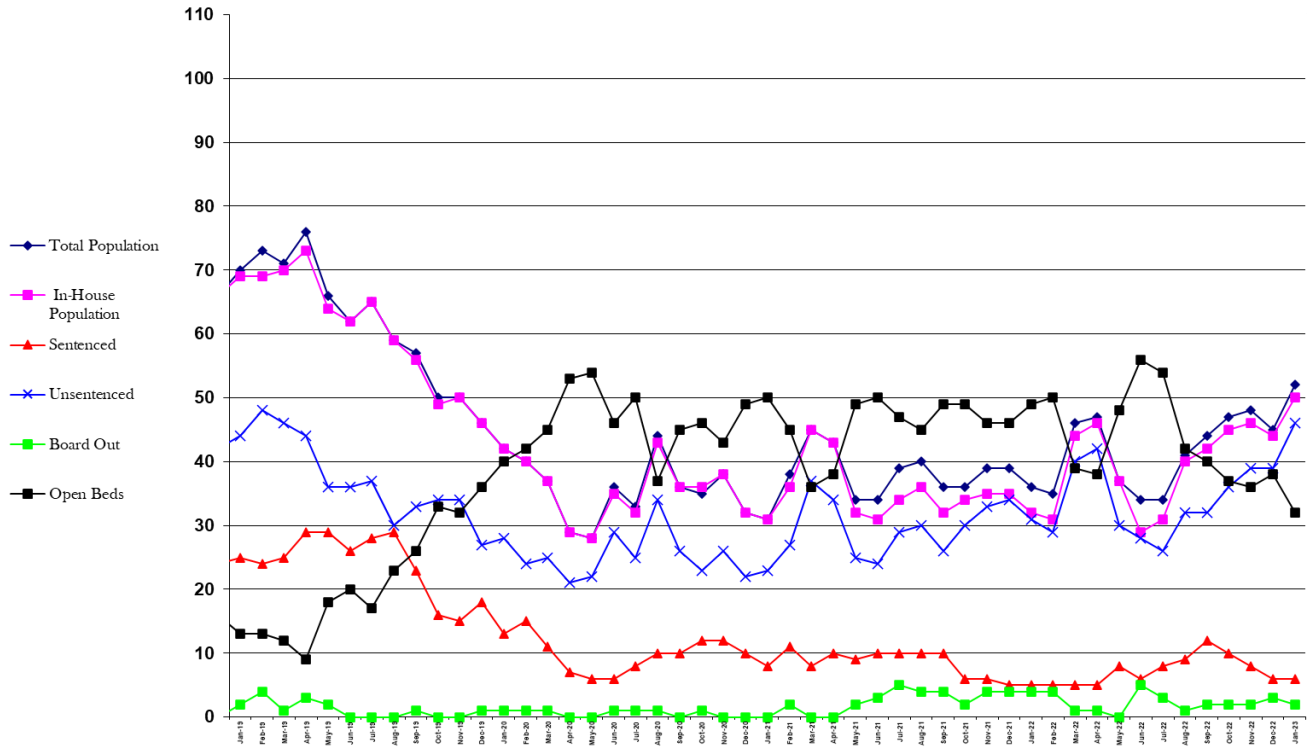

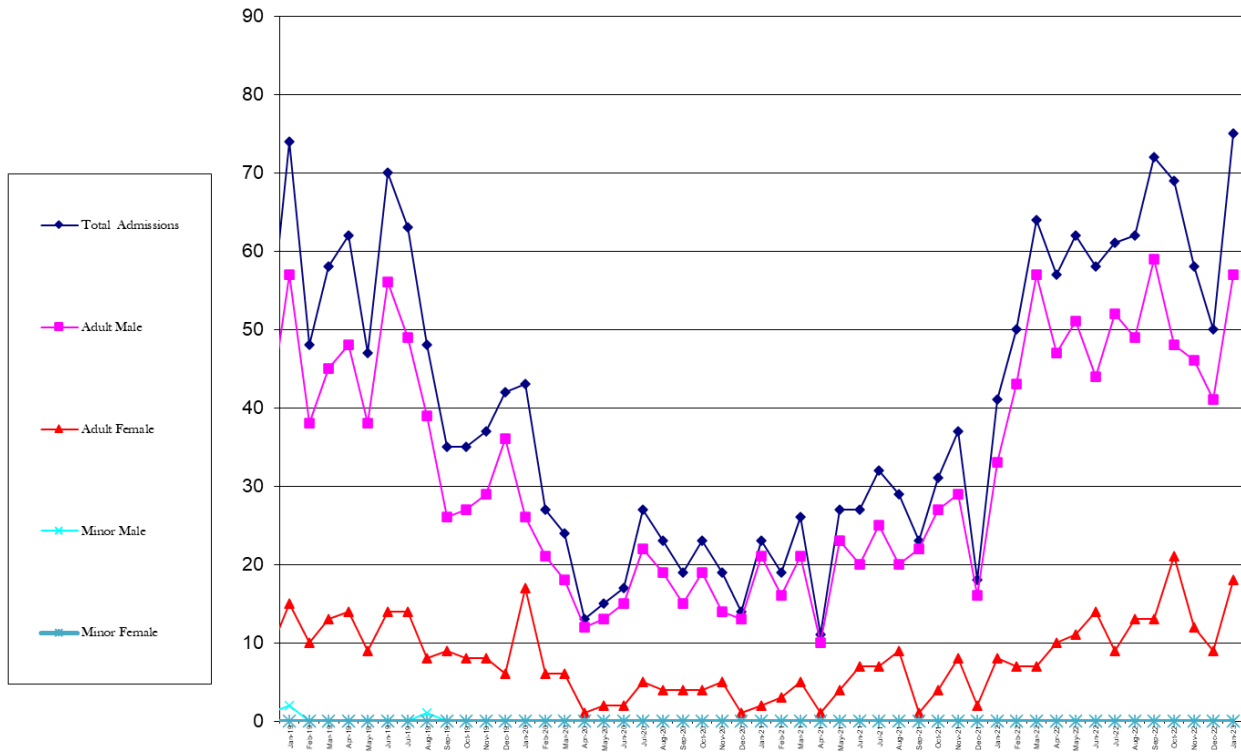

Average Jail Statistics

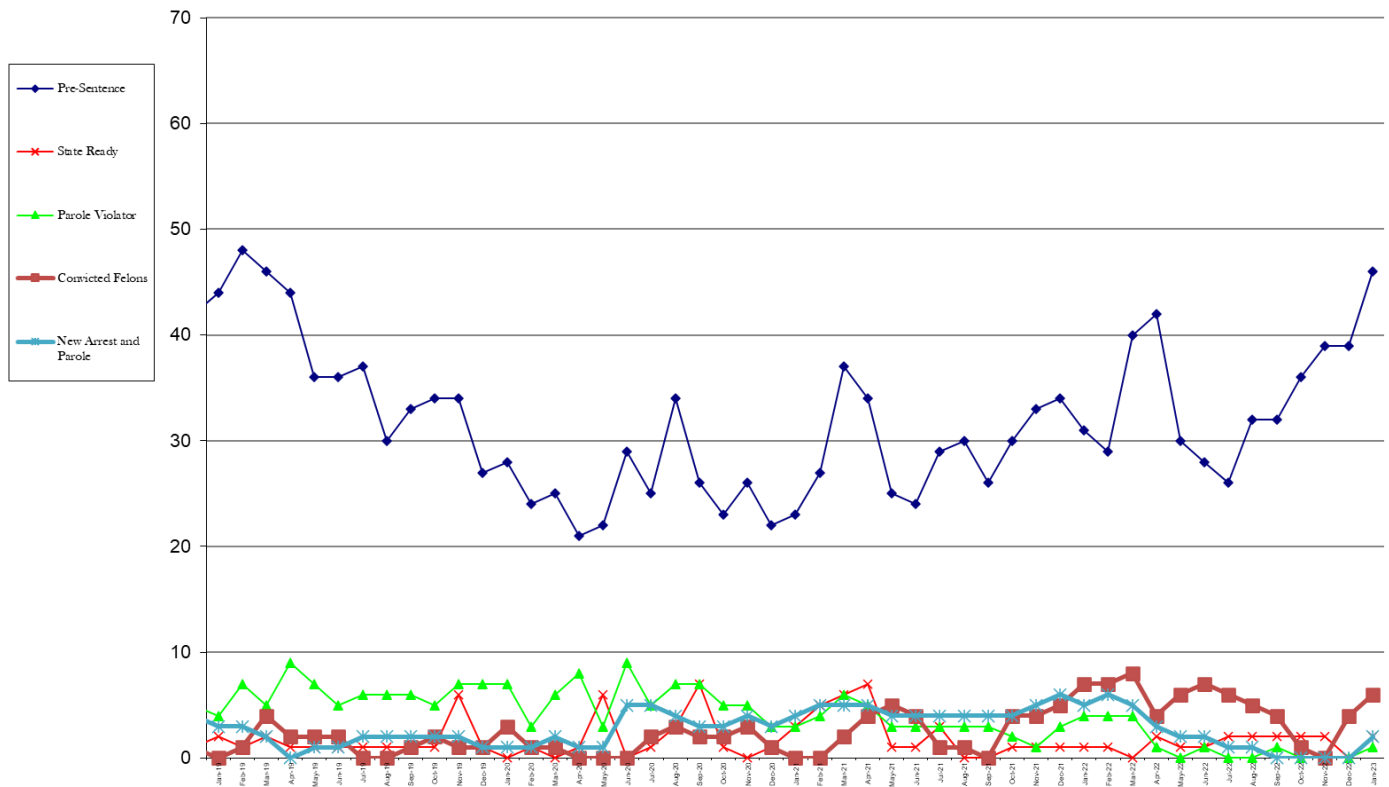


Monthly Admission Totals

Activities Continued

- January 6th, 2023 – Sergeant Marc Ninivaggi and Sergeant Kipp Rainbow earned the FBI Law Enforcement Executive Development Association Trilogy Award. To earn the FBI LEEDA Trilogy Award an individual must successfully complete the Supervisor Leadership Institute, Command Leadership Institute, and Executive Leadership Institute. Each course is 4½ days long



- January 9th, 2023 – Deputy Jim Rolfe received the Kiwanis Officer of the Month award for his life-saving effort on April 22, 2022. Deputy Rolfe was assigned to Airport Duty when a male subject suffered a cardiac incident and became unconscious. Deputy Rolfe administered a shock using an AED device until other medical responders could respond. Deputy Rolfe's quick and prompt actions resulted in a life saved.

- January 9th, 2023 – Law Enforcement Appreciation Day



- January 22, 2023 – Officer Jennifer Schulze was promoted to Corrections Sergeant. Sergeant Schulze began her career as a Corrections Officer with Oneida County Correctional Facility in 2008. She then transferred to Tompkins County Sheriff's Office Corrections Division in 2012 where she became a member of the Project Lifesaver Team and a certified Field Training Officer. Sergeant Schulze also became an important member of the Crisis Negotiations Team as of 2021.



Activities Continued

- January 24th & 25th, 2023 – Sergeant Slocum attended an intensive two-day training focused on the latest techniques for interviewing victims, witnesses, and suspects. Sergeant Slocum learned how to develop rapport and trust with those they are interviewing and how to craft effective interviews that can lead to the truth.



- January 15th & 16th, 2023 – Received two commendations for two separate incidents regarding multiple TCSO Deputy's professionalism, receptiveness, and performance.

I commend the performance of Investigator Rumsey when he stopped me on Rt. 13 around 5:45 pm for failing to turn on my headlights. He was professional, respectful, reassuring, and above all friendly and considerate. He provided invaluable help to me by securing a tow truck, because my car had gotten stuck in the ditch on the side of the road. I was a long way from home, it was dark and cold, and his management of the entire situation was reassuring and left me with a favorable impression of your office and Tompkins County in general. My only regret is that I forgot to wish him a safe completion of his duties that night.

I recently involved the Sheriff's office into a domestic/trespass situation I was in.

I didn't get the full names and badge numbers of the 2 officers who arrived, but the male officer was helpful, receptive to all perspectives of the story, and patient throughout the process until everything was resolved.

The female officer - Ms. Barber was equally helpful. She was empathetic, stern, and helped me a lot by way of what she said to me. She had no-nonsense approach and was authentic.

I don't know any cops personally, and I don't know all the in's-and-out's of their job descriptions, but I am proud to say these 2 responding officers serve my community.

I am grateful to know that among all the horror stories you hear about police nationwide, that these 2 police officers showed up promptly, acting as fair, concerned & balanced.
